

Mini Meet West 2018

Release, Waiver of Liability and Assumption of Risk Agreement

Read carefully before signing.

Mini Meet West 2018 will be held in the Columbia River Gorge area between June 25th through June 29th, 2018. Mini Meet West 2018 will include driving activities (such as a Rallye, Hill climb and transit to and from events), static displays, social gatherings and related activities.

IN CONSIDERATION of being allowed to participate in any way in Mini Meet West 2018 ("the Event"):

1. Insurance Requirement: I represent that my vehicle(s) is properly insured with the minimum coverages required by state law and I will provide proof of such insurance coverage if requested by Event organizers. Further I agree to obey all traffic laws and regulations while participating in the Event and to behave in a safe and responsible manner.
2. I understand that: a. Participation in the Event involves RISKS AND DANGERS, of serious BODILY INJURY, including PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); b. The SOCIAL AND ECONOMIC LOSSES and/or damages which could result from those risks COULD BE SEVERE; c. These risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others, the rules of the Event, the condition and layout of any prescribed course, or THE NEGLIGENCE OF THE "RELEASED PARTIES" NAMED BELOW; d. There may be OTHER RISKS NOT KNOWN TO ME or that are not readily foreseeable at this time.
3. In regard to driving activities, I understand and agree that, although I may have been supplied with certain information/directions on the prescribed Event course, the nature of the Event may not permit me to inspect the prescribed course or any portion of the prescribed course or the immediately adjacent areas thereof with which I may come in contact during the Event prior to my participation in the Event. I understand and agree that, if at any time, I feel anything to be UNSAFE, I will immediately take all necessary precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further in that portion of the Event.
4. I ACCEPT AND ASSUME SUCH RISKS AND RESPONSIBILITIES FOR THE LOSSES AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH arising out of or related to the Event, even if caused, in whole or in part, by the NEGLIGENCE OF THE "RELEASED PARTIES" NAMED BELOW.

5. I HEREBY DISCHARGE AND COVENANT NOT TO SUE Oregon Mini Society, its officers, directors, members, Event participants, officials, car owners, drivers, crew members, rescue personnel, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT, premises, and event inspectors, underwriters, consultants, and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT and each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "RELEASED PARTIES," FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THERE FORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

I HAVE READ THIS RELEASE, WAIVER AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
